**Performance Security:  
For General Election:**  
The Agency for due and punctual performance of its obligations during the contract period, has to delivered to the authority an unconditional Bank Guarantee of the Contract amount/accepted consultancy cost (equivalent to General Election Fee) towards Performance Security 15 days from the issuance of LOI and in any case prior to the signing of the agreement. The Bank Guarantee(s) shall be in the format as given in Appendix V. If performance of Services by the Consultant is not found satisfactory as per terms hereof, Authority shall be entitled to forfeit this Performance Security or part thereof as genuine pre-estimated losses for damages suffered by the Client. In addition, the Consultant shall be liable for action under other clauses of this Agreement. The said Bank Guarantee will be released within 15 (Fifteen) days after the settlement of all dues and payments, provided the Agency shall provide Bank Guarantee equivalent to 10% of the value of Fee for Assembly Election. The balance 90% of the

The Agency shall be required to submit acceptable Bank Guarantee/DD for an amount equal to **5% of the accepted consultancy cost** towards Performance Security 21 days from the issuance of LOI and in any case prior to the signing of the agreement. The Bank Guarantee will remain valid from the Effective Date till the period falling **15 (Fifteen) days after the completion of Services (after completion of Assembly election) hereunder**. The Bank Guarantee(s) shall be in the format as given in Appendix V. The Bank Guarantee(s) shall be released after expiry of 15 (Fifteen) days from the satisfactory completion of the Services. If performance of Services by the Consultant is not found satisfactory as per terms hereof, Authority shall be entitled to forfeit this Performance Security or part thereof as genuine pre-estimated losses for damages suffered by the Client. In addition, the Consultant shall be liable for action under other clauses of this Agreement.
